

Mashreq AED 1 offer at Pizza Hut

Offer Details:

- Choose between 1 (one) Single Melts Meat Lovers with a drink OR 1 (one) Single Melts Chicken Shawarma with a drink OR 1 (one) Single Melts Pepperoni Lovers with a drink OR 1 (one) Single Melts Spicy Chicken Ranch with a drink for AED 1 ("Offer") using your Mashreq Credit or Debit Card ("Mashreq Card") at any Pizza Hut retail outlet ("Pizza Hut") across the UAE on the 25th June 2025 (10:00 Hrs. to 23:59 Hrs.) ("Offer Day").
