



## Mashreq AED 1 Offer at Burger King and Texas Chicken

## Offer Details:

- Choose between a 1 (one) Cheeseburger with value fries and value soft drink OR 1 (one) Chicken burger with value fries and value soft drink OR 1 (one) Bean Burger with value fries and value soft drink) at any Burger King outlet ("BK") for AED1 using your Mashreq Credit or Debit Card ("Mashreq Card") across the UAE on the 16<sup>th</sup> of June 2022 (0800 Hrs. to 2359 Hrs.)
