- Mashreq shall not be in breach of its obligations or otherwise be liable to conduct
  the Offer as a result of any Force Majeure Event. A Force Majeure Event in these
  terms and conditions, shall mean circumstances beyond the reasonable control of
  Mashreq and unforeseeable situations including, amongst other things, acts of
  God, industrial disputes, acts and regulations of any governmental or authority in
  any jurisdiction, epidemics, pandemics, diseases or public health emergencies, etc.



- In such circumstances, Mashreq's obligations to the Eligible Cardholder shall automatically stand discharged without the need to provide notice
- Mashreq does not offer or provide any warranties, nor accept any responsibility or liability of any kind in respect of the Offer and hereby disclaims any and all express or implied warranties with respect of the same. Mashreq shall not be responsible if the quality of goods or services provided by any merchant are not up to the satisfaction of Eligible Cardholders.
- These Terms and Conditions are to be read in conjunction with Mashreq's Credit Card general terms and conditions governing the card and the Eligible Cardholder agrees to be unconditionally bound by the same.
